

### **REQUIREMENTS**

- Rated "Marine Type" and UL certified
- Less than 12 years old from manufacture date (must be removed from service on December 31 of the 12th year)
- Correct type for boat model
- Good & serviceable condition
- Carry the correct number based on the size of the boat
- Readily accessible

#### **BOAT MODELS**

#### 2018 & NEWER

- \*\*May need to replace fire extinguishers
  - Extinguishers must be labeled 5-B, 10-B, or 20-B
  - Extinguishers labeled only as B-I and B-II are NO LONGER ACCEPTABLE

### **2017 & OLDER**

- \*\*Special rules for vessels prior to 1952 at
  - www.uscgboating.org

    Can keep extinguishers rated as Marine Type, USCG Type B:C, size I or II if serviceable (commonly referred to as B-I and B-II)
  - UL Classified 5-B:C and 10-B:C meet requirements for ALL vessels regardless of vessel model age

## WHAT DOES GOOD & SERVICEABLE MEAN?

- Pressure gauge reading or indicator must be in the operable range or position (varies per model)
- · Lock pin is firmly in place
- Discharge nozzle is clean and free of obstruction
- · No visible signs of significant corrosion, pitting, or damage
